INSTRUCTIONS

Proposer and Seconder must be members in good standing of the Jacksonville Country Club Association.

CLASSES OF MEMBERSHIP

REGULAR, SOCIAL AND SINGLE MEMBERSHIP – All Regular, Social and Single Members of the Club shall purchase or acquire in the manner hereinafter provided, and shall be the holders of, a Membership Certificate.

All Regular, Social and Single Members shall be persons 35 years of age or over. A Regular Membership held by the head of a family shall entitle the member's immediate family who reside with him to all privileges of the Club. Social Members have privileges of the clubhouse only. "Immediate family" is defined as wife and husband and unmarried daughters who reside with such Member and are not self-supporting and unmarried sons not over twenty-four (24) years of age who reside with such Member and are not self-supporting.

JUNIOR I, JUNIOR II, JUNIOR SOCIAL, AND LIMITED MEMBERSHIP – Junior I Memberships shall be held by persons under thirtyone (31) years of age. Junior II memberships ages 31 to 35. When persons under 31 years of age reach the age of 31 they shall be considered as Junior II and pay dues accordingly. When Junior II Members become Regular, Single or Social Members by reason of reaching the age of 35 years, such person will be issued a Membership Certificate in the Jacksonville Country Club Association after payment of the proper fee.

MEMBERSHIP REGULATIONS – The total number of Regular and Single Regular Memberships is not to exceed 385. The total number of Junior I and Junior II Memberships is not to exceed 50. There is no restriction on the number of Social or Single Social Memberships.
